

## Speaker of Parliament Visits Ukhaa Khudag Mine

HONG KONG, 13 September, 2013 – **Mongolian Mining Corporation** ("MMC", or together with its subsidiaries, the "Group"; SEHK: 975) today announced that Mr. Enkhbold Zandaakhuu, the Speaker of Parliament of Mongolia, visited the Group's Ukhaa Khudag mine-site on 12 Sep 2013. According to the Press office of the Parliament of Mongolia, the Speaker of Parliament, through his visit to the Ukhaa Khudag mine and the state-owned Tavantolgoi coal mine, gained firsthand insights into the actual on-site mining operations and project developments taking place in the South Gobi region, at a time when the country is intending to improve its investment climate by adopting a new law on investment and amending a number of laws closely related with the mining sector and investment policy.

The trip included a visit to the mine, its supporting infrastructure facilities as well as the Group's miners' town complete with social facilities, including newly-built apartments, a school and kindergarten complex.

Commenting on his visit, Mr. Enkhold Z. said to the press: "MMC has not only developed a coal mine but also created a mining and industrial center complete with supporting facilities. We see that the Group has worked exceptionally well in developing the Ukhaa Khudag project that has obviously involved substantial investment and, in my opinion, the entire project serves as a great example on how national mining companies should operate."

The Speaker of Parliament and the accompanying delegates will also meet local residents and authorities to hear their views with regard to facilitating a positive environment to grow the exploration and mining industry.
